The hands-on portion of the workshop focused on the people, places, and things within their plan. The participants then worked within their plan on the platform to update and integrate their information into a complete COOP Plan!

DHS/CISA: New Tool for Cyber Hunt and Incident Response

The Cybersecurity and Infrastructure Security Agency (CISA) released the <u>Untitled Goose Tool</u>, a robust and flexible hunt and incident response tool to help network defenders detect potentially malicious activity. The tool provides network defenders novel authentication and data gathering methods to use as they interrogate and analyze Microsoft cloud services.



Developed in partnership with Sandia National Laboratories, the Untitled Goose Tool can query, export and investigate Azure Active Directory, Microsoft 365, and Azure configurations.
