Cybersecurity Awareness Month: CISA Spotlight Webinars

This October during the 20th annual Cybersecurity Awareness Month, the Cybersecurity and Infrastructure Security Agency (CISA), the National Cybersecurity Alliance (NCA), and many partners and champions, will be encouraging actions we can all take to stay safe online. Expanding cybersecurity awareness of the simple steps we can all take to protect ourselves when digitally connected is critical for individuals, small business and organizations. During Cybersecurity Awareness Month, toolkits, resources, and recommended actions to reduce potential cyber threats will be provided by CISA and NCA, along with best practices to reduce risks from those threats and increase digital and online safety.

Each week in October, CISA will spotlight one of the <u>four key behaviors</u> we encourage all to take now to protect ourselves online—using strong passwords and a password manager; enabling multifactor authentication; recognizing and reporting phishing; and frequently updating software. - How to Create Stronger Passwords and Debunking Myths
 About Password Managers October 3, 2023, 2:00pm2:30pm ET. Use passwords that are long, unique, and randomly generated. Use password managers to generate and remember different, complex passwords for each of our accounts, encrypt your passwords, and secure our passwords.
- The Importance of Multifactor Authentication October 10, 2023 | 2:00pm-2:30pm ET. We need more than just a password to protect our online accounts; enabling MFA makes us significantly less likely to get hacked.
- How to Recognize and Report Phishing- October 17, 2023 | 2:00pm-2:30pm ET. If a link looks a little off, think before you click. It could be an attempt to get sensitive information or install malware.
- <u>Keeping Software Up to Date</u>- October 24, 2023 | 12:00pm -12:30pm ET. Don't delay when we see a software update notification, act promptly. Better yet, turn on automatic updates.

The Cybersecurity and Infrastructure Security Agency (CISA) is pleased to announce the release of a new resource titled, <u>Security Planning Workbook</u>, which can assist critical infrastructure owners and operators with developing a foundational security plan. This workbook is designed to be flexible and scalable to suit the needs of most facilities. It is intended for any individual who is involved with an organization's security planning efforts, including those with varying degrees of security expertise, who are charged



with the safety and security of facilities and people. This product also provides descriptions of critical elements of security planning information, offers a multitude of resources, and includes fillable fields to guide stakeholder efforts.

<u>Biden-Harris Administration Awards \$600 Million to Bolster U.S. Manufacturing of COVID-19 Tests and Announces the Re-Opening of COVIDTests.gov</u>

HHS, through ASPR, is announcing an investment of \$600 million across 12 domestic COVID-19 test manufacturers and the reopening of COVIDTests.gov to deliver COVID-19 tests for free to households across the country. Each residence can order 4 free at-home tests with free delivery via USPS.

- Limit of one order per residential address
- One order includes #4 individual rapid antigen COVID-19 tests
 (<u>COVIDTests.gov</u> has more details about at-home tests, including extended shelf life and updated expiration dates)
- Orders will ship free starting the week of October 2, 2023

These critical investments in U.S. manufacturing will improve preparedness for COVID-19 and other pandemic threats of the future, strengthen the nation's capacity to manufacture tests, and secure approximately 200 million new over-the-counter COVID-19 tests for future federal government use. - Florida Professional Emergency Manager—Health Care: This certification recognizes devoted experienced Emergency Managers who possess advanced and diverse knowledge, skills, and abilities to perform effectively within a comprehensive Emergency Management program. In addition, they possess advanced knowledge, skills and abilities to perform effectively within a comprehensive realm of a health care emergency management program.
- Florida Associate Emergency Manager—Health Care: This certification recognizes devoted individuals who possess the knowledge, skills, and abilities to perform effectively within a comprehensive Emergency Management program or within a profession directly related to or in support of a comprehensive Emergency Management program. In addition, they possess advanced knowledge, skills and abilities to perform effectively within

knowledge, skills and abilities to perform effectively within a comprehensive realm of a health care emergency management program.
