## **January is National Blood Donor Month**

Did you know that every two seconds someone in the United States needs blood? January is National Blood Donor Month and an urgent call for blood donors has been issued by blood centers across the country, including OneBlood, LifeSouth, and the American Red Cross.

When it comes to blood and platelet donations, the winter season is often filled with hurdles as blood drives compete with things such as seasonal illnesses and inclement weather. A donation shortfall over the winter holidays has prompted an emergency call for blood and for platelet donors to give now to prevent a blood shortage from continuing throughout winter and affecting patient care. All blood types are needed. Additionally, there is an increased need for O Negative and O Positive blood, as well as platelet donations.

Both OneBlood and LifeSouth Community Blood Centers have collection centers and run blood drives in the TBHMPC region, providing blood products to the hospitals here. Both organizations also offer incentives to blood donors as well.

OneBlood— Every time you donate, you are not just giving hope, you are also earning rewards. These include gift cards, bonus bucks, and other promotions. To learn more, visit One-Blood's website here.

#### **Cervical Cancer Awareness Month**

Each year, doctors in the United States diagnose more than 14,000 cases of cervical cancer in women. Congress designated January as Cervical Cancer Awareness Month to bring attention to this important health issue.

This cancer, which forms in the lower part of the uterus, can prove fatal if undiagnosed. That's why early detection through routine screenings and prompt treatment can save lives.

Florida Department of Health in Pinellas County office manages the Breast and Cervical Cancer Early Detection Program, which provides vouchers for no-cost breast and cervical cancer screenings for low-income women between the ages of

Almost all cervical cancer is caused by the Human Papillomavirus (HPV). Although nearly all people will be exposed to HPV in their lifetime, there is a safe and effective vaccine which can prevent 90% of HPV related cancers. Nearly 100 million doses of the vaccine have been administered during the past decade, and it is considered both safe and effective. Learn more about this vaccine at The Power to Protect website.

### ASPR TRACIE Resource Spotlight: Innovations in Health Care Capacity Management

The articles in this issue of The Exchange (Issue 18) focus on the experiences and lessons learned by health care facilities and systems during the early phases of the pandemic and beyond, to include the "tripledemic" (respiratory syncytial virus, influenza, and COVID-19) that affected children in the state of Washington and across the U.S. during the winter of 2022-2023. We examine the history and evolution of the Southwest Texas Regional Advisory Council with a focus on their efforts to load patients during mass casualty incidents and public health emergencies. Subject matter experts from California discussed the unique characteristics and challenges

faced by Imperial County and how tents and the use of an alternate care site bolstered patient care. Our final article highlights the experiences of a Navajo Area Indian Health Service hospital working around the clock to locate appropriate receiving facilities and provide care in place while simultaneously managing staffing shortages.



#### ASPR Supports Communities Responding to Mass Shootings

ASPR helps the country prepare for, respond to, and recover from public health emergencies and disasters. ASPR routinely responds to severe weather events such as hurricanes and tornadoes and to disease outbreaks such as COVID-19 and mpox. Less routine, but increasingly more frequent, ASPR provides support during responses to and recovery from a mass shooting event. ASPR recently responded to the mass shooting incident in Lewiston, Maine. That response highlights how we support communities to respond to and recover from these horrific events. - 50% attendance of county level meeting in person or virtual (camera on to receive virtual credit)
- Participate in at least 2 drills or exercises provided by TBHMPC (fiscal year)
- Participate in the TBHMPC Communications Drill (June/December)
- Participate in the TBHMPC Regional HVA process
- Timely submission of CEMP
- Be a good community partner (bonus points)



## Seniors in Care Facilities Have More Protection Available This Year: CDC Encourages Vaccination Against Flu, COVID-19, and Respiratory Syncytial Virus (RSV)

New research finds that most nursing home residents haven't received an updated COVID-19 vaccine or the new RSV vaccine. This year, for the first time, vaccines are available to protect older adults in the United States against all three fall and winter respiratory illnesses: influenza, COVID-19 and RSV. Older Americans who are not vaccinated are at greater risk of serious illness. Leading up to this virus season, and throughout the fall, CDC has worked with other federal agencies, state and local health departments, and health care partners to address vaccine access issues and encourage vaccine uptake. Health care providers can continue to do their part by offering recommended vaccinations to residents. Nursing homes are encouraged to collaborate with state, local, and federal public health, and long-term care pharmacy

partners to address barriers contributing to low vaccination coverage. Vaccination is a key way to prevent severe disease, hospitalization, and death from flu, COVID-19, and RSV. #### Disaster Preparedness for Hospitals & Healthcare Organizations from TEEX

Pasco County Emergency Management will be hosting MGT 341 - Disaster Preparedness for Hospitals & Healthcare Organizations on January 24-25, 2024 at the Pasco EOC in New Port Richey. This course introduces the various natural, technological, and civil hazards, to which hospitals and healthcare organizations may be vulnerable, and the potential impacts of those hazards. Federal guidelines and legislation that serve to aid in the preparedness for, and response to, incidents involving these hazards are discussed, as are current emergency management standards for the hospital community. Participants review response and recovery issues that should be addressed by medical facilities and organizations in preparation for a large-scale incident, including identification of critical resources necessary for response and recovery. This week-long event includes a variety of advanced all-hazards trainings that will ultimately culminate into an Incident Capstone Event (ICE) full-scale exercise. The CDP Travel Office arranges each student's airfare, ground transportation, onsite accommodations, and meals to ensure a positive, seamless experience.
