## CDC Issues Health Advisory on Increase in Global and Domestic Measles Cases and Outbreaks

On March 18, CDC issued a Health Alert Network (HAN) health advisory to inform clinicians and public health officials of an increase in global and U.S. measles cases. This HAN also provides guidance on measles prevention for all international travelers ages six months and older and all children ages 12 months and older who do not plan to travel internationally.



From January 1 to March 14, CDC has been notified of 58 confirmed U.S. cases of measles across 17 jurisdictions, including seven outbreaks in seven jurisdictions compared with 58 total cases and four outbreaks reported the entire year in 2023. Among the 58 cases reported in 2024, 54 (93%) were linked to international travel. Most cases reported in 2024 have been among children ages 12 months and older who had not received MMR vaccine. Many countries, including travel destinations such as Austria, the Philippines, Romania, and the United Kingdom, are experiencing measles outbreaks.

To prevent measles infection and reduce the risk of community transmission from importation, all U.S. residents traveling internationally, regardless of destination, should be current on their MMR vaccinations. Health care providers should ensure children are current on routine immunizations, including MMR. Given currently high population immunity against measles in most U.S. communities, the risk of widescale spread is low. However, pockets of low coverage leave some communities at higher risk for outbreaks.

### **NETEC: New Guidance on Mpox Virus Waste**

The U.S. Department of Transportation's Pipeline and Hazardous Materials Safety Administration has collaborated with the CDC to address an emerging challenge: the handling of diagnostic samples and clinical waste containing Mpox virus (MPXV).

The advice published on March 11, 2024, clarifies that diagnostic samples and clinical waste containing MPXV Clade I or II should be designated as Category B infectious substances except when they contain or are contaminated with cultures of Clade I MPXV. ## Biden-Harris Administration Announces \$39.4 Million in Funding Opportunities for Grants through the Substance Abuse and Mental Health Services Administration (SAMHSA)

The U.S. Department of Health and Human Services (HHS), through the Substance Abuse and Mental Health Services Administration (SAMHSA), has announced notices of funding opportunities for grant programs addressing behavioral health across the country. The grant opportunities total \$39.4 million and are part of the Biden-Harris Administration's priorities to beat the overdose epidemic and tackle the mental health crisis – two key pillars of the President's Unity Agenda for the nation.

"We are building a truly integrated, equitable and accessible behavioral health care system," said HHS Secretary Xavier Becerra. "Our efforts to change the way mental health is viewed and treated in this country are making it possible for more people to get the care and support they need. This funding is a critical investment that the Biden-Harris Administration is making to strengthen behavioral health in America." Read the full press release from SAMHSA.

# **TBHMPC Moulage Training for Mass Casualty Incidents**

The Tampa Bay Health and Medical Preparedness Coalition partnered with USF Health Center for Advanced Medical Learning and Simulation (CAMLS) and Moffitt Cancer Center to hold Moulage Training for Mass Casualty Incidents. Hosted by Moffitt, we brought together representatives from hospitals and partner organizations to learn how to create fake injuries to add realism to disaster exercises. Dr. Melissa Milner and Tiffany Sanchez from CAMLS taught multiple techniques for creating real-looking injuries, using cost-effective and easy to attain materials. Students got the opportunity to create their own injuries using these techniques, with very realistic results! The Coalition will be providing participating organizations with some moulage supplies prior to the May 2nd Mass Casualty Exercise!
